2. HAZARDS IDENTIFICATION

EFFECTS FROM ACUTE EXPOSURE:

INGESTION: May be harmful if swallowed. Causes vomiting, nausea, and diarrhea. May cause burns to mucous membranes of mouth, throat, and digestive tract.
SKIN CONTACT: Prolonged contact causes severe burns which may not be immediately painful or visible.

4. FIRST AID MEASURES

INGESTION: DO NOT INDUCE VOMITING. Drink several glasses of water or milk. Get immediate medical attention. Never give anything by mouth to an unconscious person.
